In a bid to trace the 3 goats, Elimu lost direction but fortunately reached a Teuso kraal whose authority handed him to the UPDF that subsequently brought the boy to Police. The boy looks healthy and is desirous of reuniting with his family.

Through consultation with CFPU, KAPDA and LOKADO, a decision has been reached to entrust the child to LOKADO to assist in the tracing of the parents and eventually resettle the boy.
